What is MO HealthNet?

MO HealthNet is Missouri's Medicaid Program. Individuals who do not have health insurance or need help paying for health care may be eligible for coverage through MO HealthNet.



Who is Eligible for MO HealthNet?

Eligibility for MO HealthNet depends on an individual's income, age, and health.

An individual may be eligible if they fit into any of the categories below:

- **Senior-** Age 65 and older
- **Parent or Caretaker with a Child** - under the age of 19
- **Child-** Age birth to 18
- **Women with No Health Insurance** - Age 18 to 55
- **Adult without Disabilities**
Age- 19 to 64
- **Pregnant Women-** Age 19 to 64
- **Women with Breast or Cervical Cancer-** Under age 65
- **Person with Disabilities-** No age limitation
- **Blind or Visually Impaired Adult-** Age 18 and older

Type of MO HealthNet Coverage

Once an individual is approved for MO HealthNet coverage, they will either receive coverage through Fee-For-Service (FFS) or Managed Care (MC).

FFS



FFS participants include:

- People with Disabilities
- Seniors
- Blind or Visually Impaired
- Women with Breast or Cervical Cancer

MC



MC participants include:

- Children
- Pregnant Women
- Newborns
- Families

Effective date: July 1, 2022

- MAXIMUM ALLOWABLE RATE INCREASE
- APPLICABILITY

Maximum Allowable Rate Increase

Pending Centers for Medicare & Medicaid Services (CMS) approval, effective for dates of service on and after July 1, 2022, the MO HealthNet Division (MHD) will increase the fee-for-service maximum allowable rates for the dental services listed in Attachment A. Upon approval of the State Plan amendment by CMS, MHD will update the claims processing system with the indicated maximum allowable reimbursement rates and reprocess claims paid for dates of service on or after July 1, 2022.

Medicaid in Missouri



Approximately 12.7% of all Missourians (785,000 people) live in families with incomes below the federal poverty level.



For example, a family of 4 (2 adults and 2 children) would earn less than \$27,479 a year. In that family there is no extra money after providing for the bare necessities.



Approximately 1 out of 8 Missourians receive medical and dental care through the Medicaid program.

Who are our Medicaid patients?

- Single Moms, possibly your own assistant's children
- Foster kids
- Low income adults (working poor)
- Blind
- Disabled



Enrolling with MO HealthNet



- All dentists who want to provide care to MO HealthNet participants must enroll with Missouri Medicaid Audit and Compliance (MMAC) first.
- Providers can choose to enroll as both FFS and MC providers or they can enroll as MC only. “Managed Care only” providers can only provide care to participants enrolled in MC health plans.
- Providers will be assigned a Provider ID once they complete the MMAC enrollment process. After receiving their Provider ID, providers can enroll with the MC health plans; each plan has its own credentialing process.

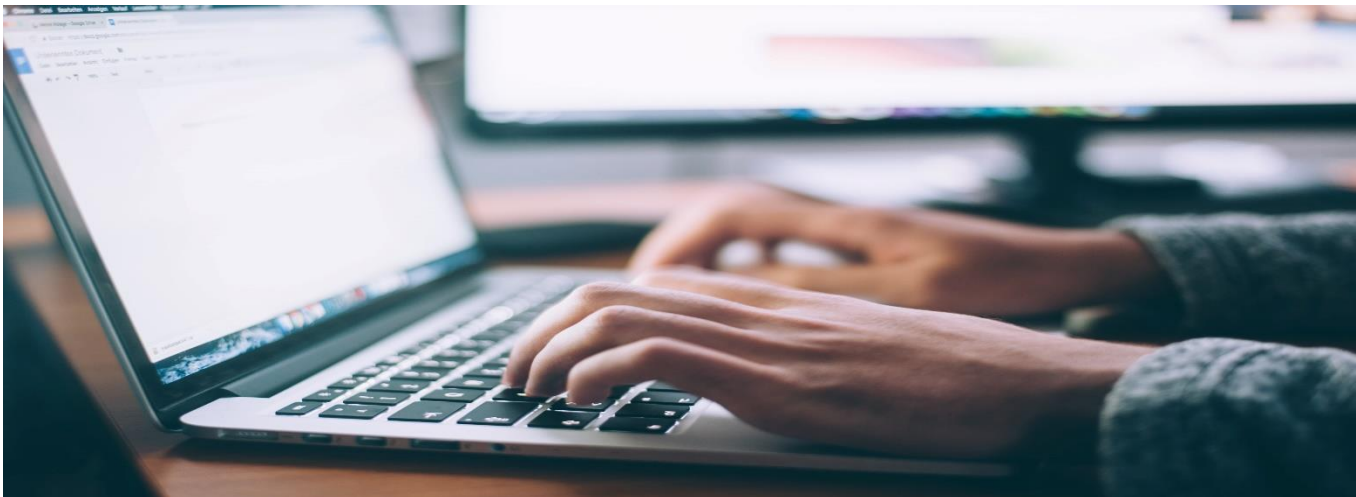

If you provide services to people with disabilities, seniors, blind & visually impaired, or women with breast or cervical cancer who get their health care services through MO HealthNet, you can provide services through the Fee-For-Service Program. Providers must be enrolled in the MO HealthNet program to provide medical services through the Fee-For-Service Program.





If you participate in the MO HealthNet program, you agree to accept MO HealthNet payment as reimbursement in full for any services provided to MO HealthNet participants. A participant cannot be billed for the difference between the MO HealthNet payment and the provider's billed charges, sometimes called "budget or balance billing."


